Religion and Sustainable Development: Towards Biodiversity and Climate Justice in Africa

Climate change now stands at the heart of sustainable development, as shifting weather patterns, relentless droughts and floods, and mounting biodiversity loss threaten the very fabric of communities. Rising poverty and environmental decline pose daunting obstacles to a sustainable future. The United Nations Sustainable Development Goals and the 2030 Agenda highlight how deeply climate action is woven into the global pursuit of sustainability. Achieving these goals demands collective action and the full mobilization of local resources, from tangible materials to the rich tapestry of socio-cultural traditions. Religion, a powerful cultural force, shapes how people interpret science and respond to policy. Practices like pilgrimage and faith communities' use of green spaces leave their mark on the environment, sometimes fueling climate change. By forging stronger connections between religious thought and climate science, we can inspire new paths toward sustainability at every level of society. Nowhere is this collaboration more urgent than in Africa, where biodiversity is vanishing at an alarming rate and religious devotion is on the rise. Sub-Saharan Africa is home to more than a fifth of the world's Christians, many of whom depend directly on nature's gifts—firewood, water, wild fruits, and fish—for their daily lives. Yet, despite this deep spiritual connection, the region faces ongoing crises: land degradation, deforestation, and the steady erosion of biodiversity. If current trends continue, Africa could lose half its bird and mammal species and up to a third of its lake productivity by the century's end. This stark reality exposes a paradox: as religious consciousness grows, so too does biodiversity loss, revealing a critical disconnect between faith, environmental stewardship, and sustainable development.

This conference brings together international scholars, scientists, religious leaders, civil activists, and policymakers to discuss the challenges and opportunities in promoting biodiversity and climate justice around the following and other related themes:
