The Malawi Journal of Social Sciences (MJSS) Editorial Policy

Focus and Scope

The MJSS is a publication of the School of Humanities and Social Sciences at the University of Malawi. The purpose of the MJSS, which is published biannually, is to serve as an outlet for publication for both emerging and established scholars in Malawi, within the region and even beyond. The MJSS publishes theoretical, empirical and review articles as well as book reviews in the field of social sciences from scholars, practitioners and students. Priority social science fields for the MJSS include demography, public administration, political and policy sciences, human resources management, social work, sociology, anthropology, psychology, history, economics and development. The MJSS is very strict with the word length of its publications. The theoretical and empirical articles shall not be more than 8000 words long inclusive of tables and references. The review articles shall not be more than 4000 words long, while the book reviews shall not be more than 800 words long.

The articles published in the MJSS are selected for their intellectual rigour, originality, practical relevance and accessibility to the wider public, academic and policy communities. The MJSS publishes submissions that meet rigorous criteria of excellence and innovation while providing authors with prompt and expert editing and peer review. In selecting the articles for publication, the Chief Editor gives preference to those of general significance that are well written, well organized, and intelligible to the targeted audiences.

In addition to the two regular issues published in April and October, the MJSS also publishes special issues focusing on topical policy and development debates in the field of social science. These special issues are either specifically commissioned by the MJSS's editorial board or the editorial board responds to proposals by a team of scholars and practitioners who want to publish a special issue on a particular topical policy and development debate. Those planning to put up a proposal for a special issue must prior to the submission of their proposal liaise with the Chief Editor for practical guidance and suggest a guest Editor as well. The MJSS shall not publish more than two special issues in a calendar year.

Peer Review Process

Articles submitted to the MJSS are subjected to a standard double blind peer review process. The papers are therefore accepted or rejected based on their own merit. Results of the review process are normally available within three months of submission. Outcomes of the review process include acceptance, acceptance with minor revisions, acceptance subject to major revisions, and outright rejection. If authors are encouraged to revise and resubmit, there is no guarantee that the resubmission will be reviewed by the same reviewers or that the revised submission will be accepted.

MJSS's Conditions for Submission

MJSS considers all submissions on condition that:

- The manuscript is the author(s)' original work, and does not duplicate any other previously published work, including the author(s)' own previously published work.
- The manuscript has been submitted only to MJSS; it is not under consideration or peer review or accepted for publication or in press or published elsewhere.

Instructions to Authors

• Submissions to MJSS should be compiled in the following order: cover letter, title page; abstract; key words; main text; acknowledgements (as appropriate); appendences (as appropriate); table(s) with caption(s) (on individual pages); figure caption(s) (as a list).

- Apart from the cover letter and title page, all submissions should not identify the names of the authors or source of finding.
- All authors of a manuscript should include their full names, affiliation(s), addresses, telephone numbers and e-mail addresses on the cover page of the manuscript. One author should be identified as a corresponding author, and should provide the affiliation where the research was conducted. If any of the co-authors changes affiliation during the peer review process, the new affiliation can be given as a footnote.
- Each author must supply a short biographical note, and if the paper is a product of funded research, author(s) must provide all details required by the funding agency and grant-awarding bodies as an acknowledgement on the title page of the manuscript.
- All articles and research viewpoints should have an abstract that briefly outlines the nature of the problem, the methodological framework, and the findings or conclusions. The abstracts should not be more than 150 words long. Each abstract must be accompanied by a list of 4 to 6 key words.
- All manuscripts should be submitted as PC compatible word file in double-spaced typescript with generous margins using Times New Roman font size 11. Figures or other artwork must be of a size and quality suitable for direct photographic reproduction and should be supplied in electronic format. All submissions properly paginated should be made to the Chief Editor at the following E-mail address: <u>mjss@unima.ac.mw</u>
- Authors are advised to use not more than three levels of subheadings unless the complexity of the argument warrants it.
- MJSS does not encourage the use of either footnotes or endnotes. If authors find it necessary, MJSS allows the use of footnotes but they should do so sparingly. The footnotes should be numbered consecutively.
- MJSS uses the Harvard (author-date) in-text citation system. These in-text citations must be in agreement with corresponding entries in the reference list. Examples include the following: 1) author, year, page number: (Chinsinga, 2007: 201-02); 2) two sources, with one author having two works in the same year: (Chirwa, 2011; Dulani, 2012b); 3) more than three authors/editors: (Senganimalunje, et al., 2013); and 4) Organization, year, volume, page number: (World Bank, 2002, 2: 1786).
- MJSS requires that the reference list must include all and only those sources cited in the text and in the footnotes or endnotes.
