## **Conference Theme**

"Religion and Sustainable Development: Towards Biodiversity and Climate Justice in Africa"

Today, climate change has become one of the central issues in the discussion of sustainable development. The increasingly changing weather patterns across the globe, evident in the recurrent droughts and floods, the rising rate of biodiversity loss, and increasing poverty, are raising critical questions on sustainable development. Goal 13 of the UN Sustainable Development Goals (SDGs) and the 2030 Agenda indicate that the world's plan of action to achieve sustainability and resilience for people and the planet is closely linked with climate (UN, 2023). According to the Paris Agreement (2015) and the 2030 Agenda, achieving the Sustainable Development Goals requires all hands-on deck. All this suggests the need to harness all the local resources, both material and social-cultural, to achieve climate justice. Religion is an essential cultural phenomenon in the world. It significantly influences people's understanding of scientific findings and the adoption of policy interventions. Besides, religious practices such as religious tourism (Pilgrimage) and religious group's use of natural green space significantly impact the environment and climate change. Therefore, fostering constructive engagements of religious thought with climate science could be foundational to building a critical mass for alternative sustainability options at the individual, community, and national levels.

The urgency of the science-religion engagement in Africa is necessary given the distressing state of biodiversity in the region (UNEP 2010) amidst growing religiosity. According to Pew Research (2018), Sub-Saharan Africa accounts for over 20% of the world's Christian population, most of whom directly depend on biodiversity products such as firewood, water,

and wild edible fruits and fish (Convention on Biodiversity, 2014). Despite this substantial Christian presence, the region continues to grapple with persistent environmental challenges, including land degradation, deforestation, and biodiversity loss (UNEP, 2010, p.1). At the current rate of overexploitation and degradation of biodiversity ecosystems, it is estimated that by the end of the century, Africa will have lost 50% of its bird and mammal species and 20-30% of lake productivity (UNEP 2016). This highlights the paradox of increasing religious consciousness and continuing biodiversity loss, suggesting a missing link in the relationship between religion, biodiversity management, and sustainable development in Africa.

This conference will bring together international scholars, scientists, religious leaders, civil activists, religious-based institutions and foundations, and policymakers to discuss the challenges and opportunities in promoting biodiversity management in Africa.
