# **CALL FOR APPLICATIONS**

## **ENROLMENT INTO THE DIPLOMA IN LAW PROGRAMME**

The School of Law, Economics and Government invites applications from eligible candidates for enrolment into the Diploma in Law Programme for the 2025/2026 academic year.

#### **ELIGIBILITY CRITERIA**

Applicants must meet the following requirements:

- (a) Possess an MSCE or its equivalent, with at least six credits, including English; or
- (b) Possess an MSCE or its equivalent, with at least five credits, including English, and at least any one of the following:
  - i. A diploma with a credit or a degree in any field from the University of Malawi or from any other accredited institution;
  - **ii.** A minimum of one year of systematic legal training in an accredited institution that trains legal personnel; or
  - iii. A certificate in law with credit from an accredited institution; or
  - iv. A diploma in law from an accredited institution; or
  - v. At least two years' experience working in a department or organization that engages in legal work, human rights activism, administrative law, commercial law, criminal law, or any other branch of the law.

### **PROGRAMME STRUCTURE AND DURATION**

- 1. The programme duration is 24 months.
- **2.** It is non-residential, and students are responsible for arranging their own accommodation.

- **3.** Teaching is delivered in eight-week direct contact blocks per semester, consisting of lectures, seminars, and tutorials. These blocks are followed by a two-week examination period.
- 4. Each teaching block and examination period is separated by a period of time that may be up to one month or less, during which students are required to complete various assignments.

#### **TUITION FEE**

- The tuition fee for each student in this programme is **MK1,520,000.00** per academic year
- Payment can be made in full at the beginning of the academic year or in two equal instalments with each instalment due before registration for the respective semester.

### **APPLICATION PROCEDURE**

Interested individuals must complete an online application at *https://clea.unima.ac.mw* or hand-deliver their application.

Applicants must submit the following documents either by uploading them or delivering them in person:

- A passport-sized photograph.
- Certified copies of academic certificates or results notifications, authenticated by a Commissioner for Oaths
- Proof of payment of a non-refundable processing fee of MK 30,000.00, deposited into the following bank account:

- A letter expressing interest in joining the programme
- Where applicable, an employment verification letter from the relevant authority, confirming the applicant's work period.

Female candidates are encouraged to apply.
