THE ASSESSMENT EXERCISE

The assessment exercise will be conducted on Thursday, 17 July 2025, and the shortlisted candidates must report to the Law Building at the University of Malawi by 6:00 a.m. on the same day.

ALL candidates **MUST** bring the following:

- Original certificates or formal notification of their MSCE or its equivalent;
- Original or certified copies of their Diploma or Degree certificate (as applicable);
- Identification document (National Identification Card, Drivers' License, or Passport); and
- Letter from employer confirming the number of years worked in a department or organization that engages in legal work, human rights activism, administrative law, commercial law, criminal law or any other branch of law (where applicable).

Candidates will be required to undergo a verification exercise. Those whose documentation does not confirm the information on the application form will not be allowed to sit for the assessment exercise.

The names of the successful candidates will be released in time for the start of the new academic year in September 2025. Shortlisted candidates are expected to make their own transportation and accommodation arrangements.
